**I. STATEMENT**

1. On May 6, 2019, DNC Parks & Resorts at Rocky Mountain Park Inn, Inc., doing business as Ridgeline Tours (Applicant) filed the application described in the caption above.

2. On May 29, 2019, Estes Valley Transport, Inc. (EVT) filed an Intervention.

3. On June 27, 2019, by Decision No. R19-0557-I, a procedural schedule was adopted to govern this proceeding and a hearing was scheduled to be held on September 19, 2019.

4. On July 19, 2019, Applicant filed its Unopposed Motion to Reschedule Hearing Date and Other Procedural Scheduling Items. Applicant requests that the scheduled hearing be vacated and other procedural deadlines be modified accordingly.

5. Applicant and EVT are the only parties to this proceeding. Applicant states that the requested relief is unopposed.

6. The request being unopposed, it is appropriate that response time be waived.

7. Based upon good cause shown for the unopposed relief, the motion will be granted.

## II. ORDER

### A. It Is Ordered That:

1. Response time to the Unopposed Motion to Reschedule Hearing Date and Other Procedural Scheduling Items filed on July 19, 2019 by DNC Parks & Resorts at Rocky Mountain Park Inn, Inc., doing business as Ridgeline Tours is waived and the request is granted.

2. The hearing scheduled to commence in this proceeding on September 19, 2019 is vacated.

3. The remainder of the procedural schedule is vacated.
