**I. STATEMENT, FINDINGS, AND CONCLUSIONS**

1. On October 9, 2019, Calder Louis Vasold commenced this proceeding by filing the above-captioned Petition. During the Commission’s weekly meeting held October 23, 2019, the matter was referred to an Administrative Law Judge (ALJ) for disposition.

2. The Petition seeks a waiver of Rule 6713 of the Rules Regulating Transportation by Motor Vehicle, 4 *Code of Colorado Regulations* 723-6. That Rule prohibits transportation network companies from allowing drivers who are not medically examined, certified, and qualified to drive to log into to their digital networks.

3. With his Petition, Mr. Vasold provided a “TNC Medical Examination Report” (Report). The Petition indicates that Mr. Vasold provided “[a] copy of all of the completed pages of the TNC Medical Examination Report.” Petition at 2. But, the Report submitted with the Petition is incomplete. Specifically, the pages of the Report that were submitted indicate that it is four pages long, but only three pages were submitted. More importantly, a portion of page three

of the Report was cut-off and, therefore is incomplete.<sup>1</sup> That page includes incomplete medical examiner notes concerning specific conditions or circumstances directly relating to whether Mr. Vasold is medically qualified to drive for a transportation network company.

4. As detailed below, the ALJ will give Mr. Vasold an opportunity to submit the complete report. After Mr. Vasold submits this information, the ALJ will enter appropriate orders.

**5. Mr. Vasold is on notice that if he does not submit the required information by the below deadline, his Petition may be decided based on the record, and may be denied.**

**II. ORDER**

**A. It Is Ordered That:**

1. On or before the **close of business on November 13, 2019**, Mr. Calder Louis Vasold must file a complete copy of his most recent “TNC Medical Examination Report,” including all pages and information on the report.

<sup>1</sup> The Report is formatted to be horizontal, which means that information is printed and hand-written horizontally across the document, rather than vertically. It appears that page three of the Report was copied vertically, rather than horizontally; the result is that the copy Mr. Vasold submitted with his Petition is missing information.

2. This Decision is effective immediately.
