**I. STATEMENT**

1. On January 2, 2020, the Colorado Public Utilities Commission (Commission) opened Proceeding No. 20M-0002T as a repository proceeding for the filing of the 2019 Colorado High Cost Support Mechanism (HCSM) Worksheets by all telecommunications service providers in the State of Colorado in accordance with Rule 2845 of the Commission's Rules Regulating Telecommunications Services and Providers of Telecommunications Services, 4 *Code of Colorado Regulations* (CCR) 723-2.

2. On January 15, 2020, the Commission referred this proceeding to an Administrative Law Judge (ALJ) by minute entry. The proceeding was subsequently assigned to the undersigned ALJ.

3. In accordance with Rule 2845, 4 CCR 723-2, each telecommunications service provider in the State of Colorado over which the Commission has jurisdiction is required to file a completed HCSM Worksheet (hereinafter, CHCSM Report Form) on or before March 31st for the preceding calendar year.

4. On March 10, 2020, the following entities filed motions for extension of time to and including April 30, 2020 to file their CHCSM Report Forms based upon the grounds stated in each motion:

- Combined Public Communications, LLC;

- Victory Telecom, Inc.

5. Based upon good cause shown, the motions will be granted for the grounds stated in each motion, which are incorporated herein by reference.

**II. ORDER**

**A. It Is Ordered That:**

1. The Motions of Extension of Time to File Colorado High Cost Support Mechanism (CHCSM) Report Forms filed on March 10, 2020, are granted.

2. On or before April 30, 2020, each of the following entities shall file its 2019 HCSM Worksheets (*i.e.*, CHCSM Report Forms) as required by Rule 2845 of the Rules Regulating Telecommunications Services and Providers of Telecommunications Services, 4 *Code of Colorado Regulations* (CCR) 723-2:
