I. STATEMENT

1. On January 2, 2020, the Colorado Public Utilities Commission (Commission) opened Proceeding No. 20M-0007T as a repository proceeding for the filing of the 2019 annual reports by eligible telecommunication carriers (ETCs) in the State of Colorado in accordance with Rule 2187(g)(IX) of the Commission's Rules Regulating Telecommunications Services and Providers of Telecommunications Services, 4 *Code of Colorado Regulations* (CCR) 723-2.

2. On January 15, 2020, the Commission referred this proceeding to an Administrative Law Judge (ALJ) by minute entry. The proceeding was subsequently assigned to the undersigned ALJ.

3. In accordance with Rule 2187(g)(IX) of the Commission's Rules Regulating Telecommunications Providers, 4 CCR 723-2, in order for an ETC previously designated by the Commission, or previously designated by the Federal Communications Commission, to be

certified to receive federal support for the following calendar year, or to retain its ETC designation, it shall file with the Commission, on or before April 30 of each year, an annual report for the preceding calendar year.

4. On April 28, 2020, AT&T Corp. and Teleport Communications America, LLC filed motions requesting highly confidential treatment of certain information contained in their 2019 DR525 forms on the grounds stated therein.

5. Based upon good cause shown, the motion will be granted for the grounds stated in the motion, which are incorporated herein by reference.

II. ORDER

A. It Is Ordered That:

1. The Motion Requesting Highly Confidential Treatment for Certain Information filed on April 28, 2020 by AT&T Corp. is granted.

2. The Motion Requesting Highly Confidential Treatment for Certain Information filed on April 28, 2020 by Teleport Communications America, LLC is granted.

3. This Decision is effective immediately.
