I. BY THE COMMISSION

A. Statement

- 1. On December 20, 2019, Public Service Company of Colorado (PSCo) filed the Application described in the caption.
 - 2. On the same day, the Commission issued notice of the Application.
- 3. On January 10, 2020, Trial Staff of the Commission filed a notice of intervention by right and entry of appearance.
- 4. On January 21, 2020, the Office of Consumer Counsel filed a notice of intervention and entry of appearance.
- 5. On January 29, 2020, the Commission deemed the Application complete and referred this proceeding to an Administrative Law Judge (ALJ) for disposition. The proceeding was subsequently assigned to the undersigned ALJ.
- 6. On February 21, 2020, the ALJ issued Decision No. R20-0122-I that: (a) scheduled a prehearing conference for March 4, 2020 at 9:00 a.m.; (b) ordered the parties to confer in advance of the prehearing conference regarding a schedule for this proceeding; and (c) ordered PSCo to file a report of the results of the conferral by March 2, 2020.
- 7. On March 2, 2020, PSCo filed an Unopposed Motion to Adopt Consensus Procedural Schedule, Vacate Prehearing Conference, and for Leave to File Supplemental Direct Testimony.
- 8. On March 5, 2020, the ALJ issued Decision No. R20-0142-I that adopted the consensus procedural schedule proposed by the parties. Among other things, Decision No. R20-0142-I scheduled an in-person hearing in this proceeding for June 1 and 2, 2020.

B. Impact of Subsequent Developments on Hearings

- 9. On March 10, 2020, Colorado Governor Jared Polis declared a state of emergency over the novel coronavirus pandemic (COVID-19). Since then, Colorado State government and the Commission have been working diligently to address how to safely and effectively manage the challenges presented by COVID-19. These efforts have focused on limiting the disruption to the services delivered by the Commission (and other State agencies), while attempting to mitigate the risks to State employees and the public. For example, the Commission has been conducting its Weekly Meetings remotely, and the Commission has asked members of the public not to attend meetings in person, but to view them by webcast. Finally, public access to the building containing the Commission's offices and hearing rooms has been restricted and it is unclear when the restriction will be lifted.
- 10. Under these circumstances, the hearing scheduled for June 1 and 2, 2020 shall be converted into a remote hearing in which the participants will appear from remote locations, as provided below. The ALJ finds that holding a remote hearing is consistent with current public health advisories to prevent the spread of COVID-19. The ALJ concludes that it is in the parties' and the public interest to hold the hearing in this proceeding as a remote hearing.

C. Instructions for Participating in Remote Hearing

11. The Commission uses the web-hosted video conferencing service GoToMeeting to hold video conferences, and in this case, a remote hearing. Parties and witnesses may participate in the remote hearing by computer, or telephone. Attending the hearing by computer allows for video-conference participation in the hearing. Participating by video-conference allows parties wishing to present evidence to display exhibits on the video-conference screen and

allows others participating by video-conference to view the displayed exhibits as they are presented in a manner most similar to that which occurs during in-person hearings.

- 12. The ALJ strongly encourages all parties and witnesses to participate in the hearing using a computer, especially any party wishing to present documents for consideration during the hearing. Parties joining the hearing by telephone may view exhibits by either providing an email address where the exhibits may be sent at the time of the hearing, or by accessing the exhibits within the administrative record for this proceeding through the Commission's free E-Filing System. 
1. Instructions for Participating by Telephone

14. The ALJ will send an email to the parties and their counsel containing the call-in information (telephone number and the Meeting ID/Access code). The parties, their counsel, and witnesses who will participate by telephone during the remote hearing must call the phone


number included in the email when the hearing takes place. When prompted, the parties, their counsel, and witnesses must input the Meeting ID/Access Code to join the hearing.

2. Instructions for Participating by Computer

15. The email noted above that will be sent by the ALJ will also contain the URL necessary to participate in the hearing by computer. Any party, counsel, or witnesses who wish to participate in the remote hearing by computer must use a computer that is connected to the internet and has a microphone and a speaker. At the time of the hearing, please input the URL included in the email sent by the ALJ and the webpage below will appear.




Confirm your audio settings and click "Save and continue." Note: You may be prompted to allow the session to access your microphone and/or camera. Finally, you will be prompted to enter your name for identification during the session:




Alternatively, if there is any problem with the link provided above, please go to https://app.gotomeeting.com/home.html and enter the nine-digit Meeting ID/Access Code included in the email.

16. If you do not want others participating in the hearing to see you, please click on the camera icon contained in the green circle at the bottom of the video screen. The icon will turn white and a slash will be placed over the camera icon indicating that your camera has been turned off. Likewise, if you do not want others participating in the hearing to hear you, confirm that there is a slash over the microphone icon contained in the red circle indicating that your


microphone has been turned off. In the screenshot of the webpage below, the microphone is turned off while the camera is turned on:



Conversely, the screenshot of the webpage below shows the microphone and video icons turned on and are ready to transmit video and audio when you join the hearing.




17. You can control the volume of the audio through the volume controls on your computer. The screenshot below shows the screen after joining the hearing with the camera turned on and the microphone turned off.




- 18. All participants in the hearing should mute (turn off) their microphones during the hearing until called upon by the ALJ. When prompted by the ALJ, please click on the microphone icon to turn on your microphone and then commence speaking. The red circle around the microphone icon will turn green indicating that your microphone is turned on. While you are speaking, please listen for any directions you are given by the ALJ.
- 19. To terminate your participation in the hearing, please click on the telephone handset icon with the word "Leave" underneath it and then click the "Yes" button in the pop-up


box, or the "Not now" button if you would like to stay in the meeting, as shown in the screenshots below.

Once the hearing room is selected, please click one of the "audio only" links (e.g., "Hearing Room A Audio Only (IOS)" or "Hearing Room A Audio Only (Android/Other)"), or click the play button on the black screen, to stream audio of the hearing live (with a short delay between real time and the broadcast, as noted in the screenshot above).

II. ORDER

hearing. The parties and witnesses of the public must follow the instructions stated above and

the information that will be provided by the Administrative Law Judge by email to the parties

and their counsel. The parties, witnesses, and members of the public should not attend the

remote hearing in-person.
