By the Commission:

This is an application by Mountain View Electric Association, Inc., of Limon, Colorado, for an extension of the certificate of public convenience and necessity heretofore granted by this Commission, covering extended areas located in Lincoln, Washington, and El Paso Counties, Colorado.

The matter was set for hearing after due notice to all interested parties, on Monday, August 13, 1962, at two o'clock P. M., in the Hearing Room of the Commission, 532 State Services Building, Denver, Colorado, and at the conclusion thereof, was taken under advisement.

No petitions of intervention were filed with the Commission prior to the hearing, and no one appeared at the hearing in oppositions to the application.

Applicant is a Colorado corporation, organized and existing under and by virtue of the laws of the State of Colorado relative to non-profit corporations, and is engaged primarily in the business of purchasing, transmitting, distributing and selling electricity in the Counties of Elbert, Arapahoe, El Paso, Washington, Lincoln, and Douglas, in the State of Colorado. Certified copies of Applicant's Certificate of Incorporation, as amended to date, have previously been filed with this Commission.

Applicant showed that it was found to be a public utility and granted a certificate of public convenience and necessity to serve electricity in the above-mentioned counties, by this Commission in Decision No. 49651, of February 18, 1958. In this application, it seeks an extension of its certificate to cover facilities and services now being provided in three separated areas located in El Paso, Lincoln, and Washington Counties, Colorado, immediately contiguous to the areas served under its presently held certificate.

Mr. A. C. Payne, Manager of Mountain View Electric Association, Inc. (Applicant), testified Applicant has been in the business of furnishing electric service to rural customers since 1941. Exhibit A shows the extended areas sought to be certificated in this application, together with its presently certificated area. In the additional areas, 522 customers are being served. The area identified as No. 1 is located at the southwesterly corner of Applicant's presently certificated area and adjacent to the Town of Fountain, Colorado. Here construction of lines and the supplying of service began in 1945. The areas designated as 2 and 3 are located at the southeasterly and northeasterly boundaries of the existing certificate. Construction in Areas 2 and 3 was begun in the late 40's, and extensions thereto have been made from time to time. Since these dates, no other public utilities are serving in the extended areas herein sought to be certificated except the K-C Electric Association of Hugo, Colorado. This organization also holds a certificate of public convenience and necessity granted by this Commission in Decision No. 58655, of May 11, 1962. K-C Electric Association serves Mountain States

Telephone and Telegraph Company at a location in the Northwest $\frac{1}{4}$ of Section 7, Township 12-South, Range 54-West, and Applicant has no objection to the continuation of this service.

Applicant is and has been providing electric service in two areas previously certificated to other utilities. One is in the certificated area of the K-C Electric Association located in Lincoln County in portions, or all of Township 8-South, Ranges 52, 53 and 54 West; Township 9-South, Ranges 52, 53 and 54 West; Township 10-South, Ranges 54 and 55 West; Township 11-South, Ranges 54 and 55 West. The other is in the certificated area of the Town of Fountain located in parts of Townships 15 and 16 South, Ranges 65 and 66 West. The construction of facilities in these two areas was done at a time when Applicant was operating as a membership cooperative serving members only, and as such, did not require a certificate of public convenience and necessity from this Commission. Now that Applicant is a public utility, as demonstrated by its conduct and as declared in Chapter 115-CRS 1953, as revised, its facilities in existing certificated areas of other utilities should be frozen at their present location and extensions thereto should not be made.

Applicant is financed by the Rural Electrification Administration of the United States Government and so has available to it the necessary financing to make extensions of its facilities from time to time as required. It introduced Exhibits B and C, being a Balance Sheet and Operating Statement as of April 30, 1962, and indicated there had been no substantial changes in its financial position since this date. Service in all its service area is being provided in accordance with its Tariff Colorado P.U.C. No. 1, as on file with this Commission.

It appears Applicant should be additionally certificated in the three areas for which an extension of its present certificate is sought in this application, and that its facilities now in service in the certificated areas of the Town of Fountain and of the K-C Electric Association should be frozen at their present level and extensions should not be made therefrom. The boundaries of its existing area plus the extension requested herein should be redefined to include the existing area plus the extensions thereto.

FINDINGS

THE COMMISSION FINDS:

That the Commission has jurisdiction of Applicant, and of the subject matter herein.

That the Commission is fully advised in the premises.

That the above Statement be made a part of these Findings by reference.

That public convenience and necessity require, and will continue to require, Applicant to provide electric service in the extended areas sought herein.

That public convenience and necessity require, and will require, the continued operation of its facilities within the certificated area of the Town of Fountain and in the certificated area of K-C Electric Association, Inc., but that no future extensions of this service to the customers not now being served shall be made.

ORDER

THE COMMISSION ORDERS:

That public convenience and necessity require, and will require, the continued operation and any extension thereto, as may be required from time to time, by Applicant in its existing certificated area and the extended area sought herein, and this Order shall be taken, deemed, and held to be a certificate of public convenience and necessity therefor.

That the total exterior boundary, including the presently certificated area and the extended areas is as follows:

10-South, Range 67-West; thence approximately 4.3 miles in a Northeasterly direction to the Southwest corner of Section 15, Township 10-South, Range 66-West; thence approximately 3.5 miles in a Northeasterly direction to the Northeast corner of the Southeast quarter of Section 34, Township 9-South, Range 66-West; thence West 1 mile to the Northwest corner of the Southwest quarter of Section 34, Township 9-South, Range 66-West; thence North 1 mile to the Northwest corner of the Southwest quarter of Section 27, Township 9-South, Range 66-West; thence East 1 mile to the Northeast corner of the Southeast quarter of Section 27, Township 9-South, Range 66-West; thence approximately 7.7 miles in a northeasterly direction to the point of beginning;

located in Arapahoe, Elbert, El Paso, Washington, Lincoln, and Douglas Counties, Colorado.

That the public convenience and necessity require, and will require, the continued operation of Applicant's facilities as they now exist within the certificated area of the Town of Fountain and of K-C Electric Association, but no extensions thereto to serve new or additional customers shall be made.

That Applicant shall continue the operation of its electric system and the supplying of service in the above designated areas in accordance with its schedule of rates, rules and regulations now on file with this Commission, or as the same may be hereafter amended, or changed, according to law or the rules of this Commission.

That Applicant shall continue to maintain its books and accounts in accordance with the Uniform System of Accounts as prescribed by the Commission, and shall continue to keep its practices in accordance with the Rules Regulating the Service of Gas and Electric Utilities, as presently prescribed by this Commission, now in effect and as they may hereafter be amended.

This Order shall become effective forthwith.
