IT APPEARING, That the above-entitled applications were consolidated for hearing by Commission Decision No. 88854 and that proper notice has been given pursuant to Section 40-6-108(2), CRS 1973; that no protest, objection or petition to intervene or otherwise participate in the proceeding has been filed by any person within the time prescribed and that the herein proceeding is therefore noncontested and unopposed; and that pursuant to Section 40-6-109(5), CRS 1973, the herein matter is one which may properly be determined without the necessity of a formal oral hearing.

AND IT FURTHER APPEARING, That the evidence heretofore submitted amply warrants approval of the transfer and acquisition of certain property and electrical facilities more fully described in the applications as hereinafter ordered;

WE FIND, That the transfer and acquisition is compatible with the public interest;

AND WE FURTHER FIND, That the property and facilities proposed to be transferred and acquired herein are more properly a part of Tri-State Generation and Transmission Association, Inc.'s system and that Tri-State Generation and Transmission Association, Inc., is qualified to conduct the utility operations involved herein, and that Mountain View Electric Association, Inc., should be permitted to transfer to Tri-State Generation and Transmission Association, Inc., \$219,558.67 of its indebtedness due and owing to the United States of America.

An appropriate order will be entered.




IT IS ORDERED, That Applicants named in the caption above be authorized to transfer property and facilities which are the subject of these applications and that Mountain View Electric Association, Inc., is authorized to transfer to Tri-State Generation and Transmission Association, Inc., \$219,558.67 of its indebtedness due and owing to the United States of America.

IT IS FURTHER ORDERED, That the right of Transferee to operate under this Order shall be dependent upon compliance with all present and future laws and rules and regulations of the Commission to which it is subject.

AND IT IS FURTHER ORDERED, That this Order shall become effective twenty-one days from the day, and date hereof.
