STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. On December 12, 1991, Administrative Law Judge Ken Kirkpatrick issued Recommended Decision No. R91-1614. The decision recommends that the operating authorities of a number of carriers, including Historic Denver, Inc. (Historic), be revoked for failure to have a current certificate of insurance on file with the Commission.

2. On December 20, 1991, Historic filed a letter with the Commission requesting stay of Decision No. R91-1614. The Commission will construe the letter as Exceptions to the Recommended Decision.

3. Historic states that it is a non-profit organization and it sold its vehicle. Historic further states that it does not want to procure additional insurance when it has no vehicle. Historic further requests suspension of the certificate. This request is being processed under Docket No. 92A-009CP. In order to allow Historic to proceed with the suspension request, the Commission will grant the exceptions and stay the recommended decision.

THEREFORE THE COMMISSION ORDERS THAT:

1. The Exceptions filed by Historic Denver, Inc. to Recommended Decision No. R91-1614 are granted.

2. Recommended Decision No. R91-1614 is stayed pending the disposition of Docket No. 92A-009CP. If the authority is successfully suspended the show cause proceeding in Case No 3599-Ins. is dismissed. If the certificate is not subsequently suspended, the Commission Staff is instructed to reinstitute show cause proceedings against the certificate.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this decision.

4. This Order is effective on its date of mailing.
