STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. On November 20, 1991, Theodore Limmel, doing business as East Slope deliveries, filed Docket No. 91A-769CY for temporary authority to conduct operations as a common carrier by motor vehicle for the transportation of general commodities between the Denver metro area and points in Summit County.
2. Interventions opposing the application were timely filed Pony Express Courier Corporation and RAC Transport, Inc.
3. On January 7, 1991, the Applicant sent a letter to the Commission withdrawing the temporary application. There being nothing further for the Commission to consider, the request will be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. This application is dismissed.
2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this decision.
