COMMISSION ORDER: (1) SETTING PREHEARING CONFERENCE FOR WEDNESDAY JANUARY 29, 1992 AT 1:30 P.M.; (2) GRANTING MOTION FOR EXTENSION OF TIME.

This matter came on for consideration on the Commission's own motion. On January 22, 1992, the Colorado Office of Consumer Counsel submitted the Milestone II Report, on behalf of the parties in this Docket, known as the "collaborative process", one of the four dockets which came about as part of the settlement of the 1991 Public Service Company of Colorado Rate Case. See Decision No. C91-918 (July 22, 1991) (Commission order approving Revised Settlement Agreement II).

The Commission, on its own motion, will hold a Prehearing Conference in matter on Wednesday January 29, 1992 at 1:30 p.m. At the hearing, the Commission will discuss the Milestone II Report, any proposed modifications to the Collaborative's Workplan, and will respond to the Collaborative's "Summary of Activity October 1991

- December 1991", filed on January 15, 1992 by the Parties. Finally, the Commission will discuss the "Response to Commission Decision No. C91-1549-I", filed on January 15, 1992 by the Parties. Due to the short time period, the Commission finds that the public interest and necessity requires less than 10 days notice of the hearing. See Colorado Revised Statutes § 40-6-108(4) (1991 Cum.Supp. Vol.17). (The Commission telephoned all parties with notice of the hearing on Friday January 24, 1992).

The Motion for Extension of Time to File the Milestone II Report, filed on January 15, 1992 by the Office of Consumer Counsel, is hereby granted. The Milestone II Report, filed on January 22, 1992, will be accepted.
