#### STATEMENT

#### BY THE COMMISSION:

By Recommended Decision No. R91-1170, dated December 16, 1991, Administrative Law Judge Michael Homyak dismissed the waiver application of John R. Vaught, doing business as Longmont Taxi Service (LTS). Judge Homyak dismissed the application of LTS for failure to appear at the hearing and prosecute the waiver of insurance application.

On January 6, 1992, LTS filed exceptions to the recommended decision. By the exceptions, LTS contends that it did not receive the Commission's Notice of Hearing requiring LTS to appear at the December 2, 1991 hearing. In addition, LTS contends that it's attorney of record in the matter, Brian Cook, was not served a copy of the order setting the matter for hearing.

Good cause having been shown, the Commission will grant the exceptions and reinstate the waiver application.

## THEREFORE THE COMMISSION ORDERS THAT:

- 1. The exceptions of John R. Vaught, doing business as Longmont Taxi Service, are granted. The waiver application pending under Docket No. 91A-566CP-Waiver is reinstated. The application is remanded to Judge Homyak for hearing on the merits.
