STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. On January 29, 1992, Scanticon-Denver, Inc., doing business as Scanticon-Denver, filed Docket No. 92A-051CP for temporary authority to conduct operations as a common carrier by motor vehicle.
2. The Commission gave notice of the application on February 3, 1992. Interventions opposing the application were timely filed by Fred Tiller, doing business as American Limousine Service; Yellow Cab Cooperative Assn., Inc.; Zone Cab Company; and People's Choice Transportation, Inc.
3. On March 6, 1991, the Applicant sent a letter to the Commission withdrawing the temporary application. There being nothing further for the Commission to consider, the request will be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. This application is dismissed.
2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this decision.
3. This Order is effective upon its date of mailing.
