STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. On February 26, 1992, Jerry Morris and Weston Serrano, doing business as J. West Oilfield Service, filed Docket No. 92A-080BY-Transfer-TA for temporary approval to assume operational control of Contract Carrier Permit No. B-819 pending disposition of the related application to acquire the permit from Keen Transport, Inc.

2. Proper notice of the filing of this application was given under § 40-6-108(2), C.R.S., on March 2, 1992.

3. Petitions to intervene or otherwise participate in the proceeding have been filed by R. W. Jones Trucking Company; Black Hills Trucking, Inc.; and Turner Bros. Trucking Co., Inc.
