STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. Proper notice of the filing of these applications have been given under \S 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in the proceedings has been filed by any person

within the time prescribed. These proceedings are noncontested. Under \S 40-6-109(5), C.R.S., these matters may be determined without a hearing.

- 2. The evidence submitted warrants the approval of the transfers as ordered.
- 3. The financial standing of the Transferee has been satisfactorily established and the transfers are in the public interest.
- 4. The Transferee is fit, willing, and able to properly engage in bona fide motor carrier operations under the authorities to be transferred.

THEREFORE THE COMMISSION ORDERS THAT:

- 1. Applicants are authorized to transfer Certificate of Public Convenience and Necessity PUC No. 403&I and Contract Carrier Permit No. B-1317&I subject to encumbrances, if any, against said authority.
- 2. The right of Transferee to operate under this Order shall depend on its compliance with all present and future laws and Commission rules and regulations, and the prior filing by Transferor of delinquent reports, if any, covering operations under the Certificate and Permit up to the time of transfer.
- 3. Transferee shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Transferee shall also adopt the tariffs of the Transferor which shall become those of Transferee until changed according to law. Transferee shall pay the vehicle identification fee. Transferor shall file terminating annual reports from the 1st of January to the date of this Order. Applicants shall file acceptance of transfers signed by both the Transferor and Transferee. Operations may not begin until these requirements have been met. If the Applicants do not comply with the requirements of this ordering paragraph within 60 days of the effective date of this Order then ordering paragraph 1 above, which grants authority to the Transferee, shall be void, and the authority granted shall then be void. On good

shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.
