STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. Proper notice of the filing of these applications has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in the proceedings has been filed by any person within the time prescribed. These proceedings are noncontested. Under § 40-6-109(5), C.R.S., these matters may be determined without a hearing.

2. The evidence submitted warrants the approval of the transfers as ordered.

3. The financial standing of the Transferee has been satisfactorily established and the transfers are in the public

interest.

4. The Transferee is fit, willing, and able to properly engage in bona fide motor carrier operations under the authorities to be transferred.

5. The transferee in these applications presently holds Certificate and Public Convenience and Necessity PUC No. 16114 which overlaps and duplicates, in part, the authorities to be transferred in these dockets. PUC No. 16114 will be modified to eliminate the overlap. In addition, all of the authorities will be combined into one certificate under Certificate PUC No. 16114.

THEREFORE THE COMMISSION ORDERS THAT:

1. Applicants are authorized to transfer Certificate of Public Convenience and Necessity PUC Nos. 25377 and 41891, subject to encumbrances, if any, against said authority.

2. The right of Transferee to operate under this Order shall depend on its compliance with all present and future laws and Commission rules and regulations, and the prior filing by Transferor of delinquent reports, if any, covering operations under the Certificates up to the time of transfer.

3. Transferee shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Transferee shall also adopt the tariffs of the Transferor which shall become that of Transferee until changed according to law. Transferee shall pay the vehicle identification fee. Transferor shall file a terminating annual report from the 1st of January to the date of this Applicants shall file an acceptance of transfer signed by Order. both the Transferor and Transferee. Operations may not begin until these requirements have been met. If the Applicants do not comply with the requirements of this ordering paragraph within 60 days of the effective date of this Order, then ordering paragraph 1 above, which grants authorities to the Transferee, shall be void, and the authorities granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.

4. Certificate of Public Convenience and Necessity PUC Nos. 16114, 25377 and 41891 are combined into one certificate to be known as Certificate PUC No. 16114 and the full and complete authority under this Certificate shall be as set forth in the attached Appendix.

- 5. Certificate PUC Nos. 25377 and 41891 are cancelled.
- 6. This Order is effective on its date of mailing.
