**COMMISSION ORDER
GRANTING EXTENSION**

STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in the proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

2. The evidence submitted warrants the grant of authority as requested.

3. The present or future public convenience and necessity requires or will require the transportation service as requested.

4. Applicant is fit, willing, and able to properly perform the extended service as requested.

THEREFORE THE COMMISSION ORDERS THAT:

1. Applicant is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. 47049 as follows:

Transportation of passengers and their baggage, on schedule, (1) between Stapleton International Airport in Denver, Colorado and Evergreen, Colorado serving all intermediate points between Evergreen and the intersection of I-70 and exit 256; and (2) between Stapleton International Airport in Denver, Colorado and Bailey, Colorado serving all intermediate points between Bailey and Parmalee Gulch in Indian Hills, Colorado.

2. The complete authority under Certificate of Public Convenience and Necessity PUC No. 47049 as extended, shall be as set forth in the attached Appendix.

3. Applicant, as the holder of Certificate of Public Convenience and Necessity PUC No. 47049, shall operate in accordance with the Order of the Commission except when prevented by and Act of God, the public enemy, or extreme conditions.

4. Applicant shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Applicant shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Operations may not begin until these requirements have been met. If the Applicant does not comply with the requirements of this ordering paragraph within 60 days of the effective date of this Order then ordering paragraph 1 above, which grants authority to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.

5. This Order is effective on its date of mailing.

Transportation of

passengers and their baggage,

(A) in taxi service,

between all points within a 20-mile radius of the Post Office at Evergreen lying West of a line drawn North and South through Eldorado Springs and Foxton, Colorado and between said points on the one hand and all points in the Counties of Denver, Jefferson, Arapahoe, Adams, Larimer, Boulder, Gilpin, Weld, Gunnison, Douglas, Teller, El Paso, Pueblo, Park, Clear Creek, Grand, Delta, Summit, Jackson, Routt, Eagle, Lake, Pitkin, Moffat, Garfield, and Mesa, State of Colorado, on the other hand.

(B) on schedule,

(1) between Stapleton International Airport in Denver, Colorado and Evergreen, Colorado serving all intermediate points between Evergreen and the intersection of I-70 and exit 256; and (2) between Stapleton International Airport in Denver, Colorado and Bailey, Colorado serving all intermediate points between Bailey and Parmalee Gulch in Indian Hills, Colorado.

Item (A) is restricted as follows:

1. against opening or operating an office in the Counties of Teller or El Paso, State of Colorado;
2. against service originating in Lake County, Colorado; and
3. against any trips originating in the following geographic area: All points beginning at Exit 256 of Interstate Highway I-70 and ending at Exit 252 of Interstate Highway I-70, at a point known as El Rancho on Highway 40, and within all points along this route heading West from Exit 256 one (1) mile South of Interstate Highway I-70 and one (1) mile North of Interstate Highway I-70. Additionally, no trips originating at any City and County of Denver or Adams County Airport facilities shall terminate within the geographic area described in this restriction No. 3 set forth above.
