STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

2. Williams & Isley, P.C., seek authority to encumber all right, title, and interest in and to Certificates of Public Convenience and Necessity PUC Nos. 341&I, 4445&I, 16260&I, and Contract Carrier Permit No. B-1114, held by Walt Wilson, Inc., doing business as Weicker Moving and Storage Company. Williams & Isley, P.C., hold a judgment lien in the principal sum of \$7,884.86.

3. The evidence submitted warrants the grant of the request to encumber the authority.

4. The approval sought is in the public interest and should be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. Williams & Isley, P.C., is authorized to encumber all right, title, and interest in Certificates of Public Convenience and Necessity PUC Nos. 341&I, 4445&I, 16260&I, and Contract Carrier Permit No. B-1114 to secure payment of the indebtedness in the amount of \$7,884.86.

2. Walt Wilson, Inc. and Williams & Isley, P.C., shall notify the Commission, in writing, of the full satisfaction of the above stated indebtedness, and release of the authorized encumbrance, within ten days after it has been effected.

3. This Order is effective on its date of mailing.
