**COMMISSION ORDER
GRANTING LEASE OF AUTHORITY**

STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
2. The evidence submitted warrants approval of the lease.
3. The financial standing of the Lessee has been satisfactorily established. The lease is in the public interest.
4. Lessee is fit, willing, and able to properly engage in bona fide motor carrier operations under the authority to be leased.

THEREFORE THE COMMISSION ORDERS THAT:

1. R & R Resources, Inc., doing business as Glenwood Springs Yellow Cab, is authorized to lease Certificate of Public Convenience and Necessity PUC No. 21604 for the period from July 20, 1992 through May 17, 1996, commencing on the date of this Order, from Stephen L. Vasilakis, Lessor.

2. Lessee shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Lessee shall also adopt the tariff of the lessor which shall become that of lessee until changed according to law. Lessee shall pay the vehicle identification fee. Lessor and lessee shall file an acceptance of lease signed by both parties. Operations may not begin until these requirements have been met. If the Applicants do not comply with the requirements of this ordering paragraph within 60 days of the effective date of this order, then ordering paragraph 1 above, which grants authority to the lessee, shall be void, and the lease of authority granted shall be void.

3. The right of Lessee to operate under this Order shall depend on compliance with all present and future laws and Commission reports, if any, covering operations under the Certificate up to the time of the lease.

4. This Order is effective on its date of mailing.
