# COMMISSION ORDER GRANTING TEMPORARY AUTHORITY

#### STATEMENT, FINDINGS, AND CONCLUSIONS

#### BY THE COMMISSION:

- 1. On August 10, 1992, Fleet-Car Lease, Inc., filed Docket No. 92A-387BY-TA for temporary authority to conduct operations as a contract carrier by motor vehicle for hire for the transportation of used automobiles, vans, and trucks between the Rolla Ramp facility at Henderson, Colorado, and the Denver Auto Auction at Aurora, Colorado. Restricted to providing service for only General Motors Corporation.
- 2. The Commission gave notice of the application on August 17, 1992.
- 3. By \$ 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.
- 4. Section 40-6-120(1), C.R.S., authorizes the Commission to grant temporary authority when there appears to be ". . . an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need."

- 5. The support filed on behalf of this application indicates that shipper, General Motors Corporation, requires a carrier who is able to provide comprehensive transportation-related services in connection with the movement of used automobiles, trucks, and vans between the Rolla Ramp facility located in Henderson, Colorado, and The Denver Auto Auction located in Aurora, Colorado. The carrier must qualify as a General Motors sanctioned carrier under strict safety, operational, and financial standards. In addition, the carrier must dedicate equipment to the use of General Motors for the transportation of mixed shipments of interstate and intrastate traffic in order to facilitate the orderly movement of General Motors' vehicles.
- 6. The Commission finds due to the facts stated in paragraph 5 above, there is as immediate and urgent need for additional transportation services. The Commission will grant the application.
- 7. The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority sought and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.
- 8. This application for temporary authority is in the public interest and should be granted.
- 9. The Applicant is advised that the granting of a temporary authority makes no presumption that permanent authority will be granted.

#### THEREFORE THE COMMISSION ORDERS THAT:

- 1. Fleet-Car Lease, Inc. is granted temporary authority to conduct operations as a contract carrier by motor vehicle for hire for a period of 180 days commencing from the mailed date of this order, with authority as set forth in the attached Appendix.
- 2. Fleet-Car Lease, Inc. shall not commence operation until all requirements have been met and notice in writing has been received from the Commission that the Applicant is in compliance and may begin service.
- 3. The 20-day time period provided by \$ 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsid-eration shall begin on the first day after the Commission mails or serves this decision.
