# COMMISSION ORDER GRANTING TEMPORARY AUTHORITY

## STATEMENT, FINDINGS, AND CONCLUSIONS

#### BY THE COMMISSION:

- 1. On October 21, 1992, R T Systems, Inc., filed Docket No. 92A-552BY-Extension-TA for temporary authority to extend operations under Contract Carrier Permit No. B-9708 for the transportation of (1) iron and steel pipe and the related fittings; and (2) empty propane tanks between the facilities of Thompson Pipe and Steel Company in Denver, Colorado, on the one hand, and all points in the State of Colorado, on the other hand. This application is restricted to providing service for only Thompson Pipe and Steel Company.
- 2. The Commission gave notice of the application on October 26, 1992.
- 3. By \$ 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.
- 4. Section 40-6-120(1), C.R.S., authorizes the Commission to grant temporary authority when there appears to be "... an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need."

- 5. The letter of support filed on behalf of this application indicates there is an immediate and urgent need for the service requested.
- 6. The Commission finds due to the facts stated in paragraph 5 above, there is as immediate and urgent need for additional transportation services. The Commission will grant the application.
- 7. The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority sought and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.
- 8. This application for temporary authority is in the public interest and should be granted.
- 9. The Applicant is advised that the granting of a temporary authority makes no presumption that permanent authority will be granted.

#### THEREFORE THE COMMISSION ORDERS THAT:

- 1. R T Systems, Inc. is granted temporary authority to extend operations under Contract Carrier Permit No. B-9708 for a period of 180 days commencing from the mailed date of this order, with authority as set forth in the attached Appendix.
- 2. R T Systems, Inc. shall not commence operation until all requirements have been met and notice in writing has been received from the Commission that the Applicant is in compliance and may begin service.
- 3. The 20-day time period provided by \$ 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this decision.
