STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. On November 10, 1992, Fast Wheels Delivery, Inc., filed Docket No. 92A-607BY-Extension-ETA for emergency temporary authority to extend operations under Contract Carrier Permit No. B-9698 for the transportation of general commodities between all points within an eleven-mile radius of Colfax Avenue and Broadway in Denver, Colorado, restricted to providing service for only Price Club. On November 4, 1992, the Commission at its regular Open Meeting granted Applicant an Emergency Temporary Authority under Docket No. 92A-561BY-Extension-ETA. This emergency temporary authority will expire before the Commission can act on Applicant's temporary authority application, therefore, Applicant is seeking an additional emergency temporary authority.

2. By § 40-6-120, C.R.S., the application for emergency temporary authority is under consideration for a Commission order.

3. Section 40-6-120(1), C.R.S., authorizes the Commission to grant emergency temporary authority when there appears to be "... an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need."

4. The support filed on behalf of this application indicates that the Price Club in the past has used two carriers licensed by this Commission but has been extremely dissatisfied with the service of one carrier and has had numerous business complications that have led to ill feelings with the other carrier.

Price Club also states that it tried to contact other carriers to move its goods but that they could not meet shipper's requirements or did not seem eager to solicit the business. Price Club called every carrier listed in the Yellow Pages.

5. The Commission finds, due to the facts stated in paragraph 4 above, there is an emergency need for additional transportation services. Existing carriers are incapable of providing the service, because they are either unwilling or unable to provide the needed service. The Commission will grant the application.

6. The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority sought and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.

7. This application for emergency temporary authority is in the public interest and should be granted.

8. The Applicant is advised that the granting of an emergency temporary authority makes no presumption that temporary and permanent authority will be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. Fast Wheels Delivery, Inc. is granted emergency temporary authority to extend operations under Contract Carrier Permit No. B-9698 for a period of 15 days commencing from the effective date of this order, with authority as set forth in the attached Appendix.

2. Fast Wheels Delivery, Inc. shall not commence operations until all requirements have been met and notice in writing has been received from the Commission that the Applicant is in compliance and may begin service.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves

this decision.

4. This Order is effective on November 20, 1992.
