STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S., and no protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without an oral hearing.

2. To grant the request for authority to temporarily suspend a portion of operations under Certificate of Public Convenience and Necessity PUC No. 14114 would be in the public interest.

3. The evidence submitted warrants the approval to temporarily suspend a portion of operations under Certificate of Public Convenience and Necessity PUC No. 14114 as here ordered.

THEREFORE THE COMMISSION ORDERS THAT:

1. The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 14114 that authorizes the use of vehicles with a passenger capacity of more than seven is authorized by the Commission from November 9, 1992 through May 9, 1993.

2. On or before April 9, 1993, Applicant shall file a written request either for an extension of this suspension period, or a request to reinstate full service under Certificate of Public Convenience and Necessity PUC No. 14114.

3. This Order is effective on its date of mailing.
