**COMMISSION ORDER GRANTING TARIFF CHANGES
ON LESS-THAN-STATUTORY NOTICE**

STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

On January 7, 1993, Black Hawk Central City Ace Express, Inc. (BHCE), filed an application for an order of the Commission authorizing the publication of Original Page No. 7 to Passenger Tariff, Colorado PUC No. 4, to become effective on less-than-statutory notice.

BHCE operates scheduled service between Denver and Central City/Black Hawk. BHCE has been providing service between these points since October 1, 1991.

In its application, BHCE proposes to offer a coupon that will be good for \$4 off the regularly priced (\$18) round-trip fare and the senior citizen (\$14.50) round-trip fare. The coupon will be good only from the National Western Stock Show Complex and will be redeemable until the completion of the Stock Show on January 24, 1993.

In support of the proposed tariff changes, the Applicant states

that the reduced fare will allow it to increase ridership during the time period that visitors are attending the Stock Show in Denver.

Analysis of this application has determined that the proposed reduction in fares is acceptable under BHCE's authority. The granting of the application on less-than-statutory notice is required to better serve the public.

Rule No. 31(f)(1) of the Commission's Rules of Practice and Procedure, 4 Code of Colorado Regulations 723-1, states that an order authorizing common carriers to change tariffs or time schedules on less-than-statutory notice will be entered for good cause shown.

The Commission finds that good cause has been shown for approval of the proposed changes in Passenger Tariff, Colorado PUC No. 4, and the application should be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. The application of Black Hawk Central City Ace Express, Inc. to publish Original Page No. 7 to Passenger Tariff, Colorado PUC No. 4, to become effective on less-than-statutory notice, is granted.

2. Original Page No. 7 to Passenger Tariff, Colorado PUC No. 4, as set forth in attached Appendix, shall be published and filed to become effective on not less than one day's notice to the Commission and the general public.

3. This Order is effective on its day of mailing.
