STATEMENT

BY THE COMMISSION:

On February 16, 1993, the parties to the Demand Side Management Collaborative Process ("DMSCP") filed their Stipulation and Settlement Agreement in Docket No. 91A-481EG. Attached to the Stipulation was the parties' Final Report of the Public Service Company of Colorado Collaborative Process. In the Stipulation, the parties request that the Commission accept, review, and approve the final report.

Also on February 16, 1993, Public Service Company of Colorado ("Company") filed an application for Commission approval of the demand side management programs developed in the DMSCP (Docket No. 93A-099EG). The Company has requested, in its Motion for Procedural Order, that the Commission set a prehearing conference and a hearing date on the application. We now grant the Motion for Procedural Order consistent with the discussion herein.

Since the issues in Docket Nos. 91A-481EG and 93A-099EG are closely related, the two cases are hereby consolidated. We now set a prehearing conference in this consolidated matter for April 2, 1993, beginning at 9 a.m. in Commission Hearing Room A. Unless modified at the prehearing conference, hearing is now set in this consolidated matter for April 16, 1993, beginning at 9 a.m., Hearing Room A.

At the prehearing conference, the parties shall be prepared to address any matter relevant to the conduct of the April 16, 1993, hearing (e.g., issues to be decided in this matter, witnesses to be presented at hearing regarding the stipulation, and the Company's application, and whether the Commission should set further hearings to investigate the costs and benefits of using the collaborative process, etc.).

THEREFORE THE COMMISSION ORDERS THAT:

1. Docket Nos. 91A-481EG and 93A-099EG are hereby consolidated.

2. The Public Service Company of Colorado Motion for Procedural Order is hereby granted consistent with the above discussion.
