**COMMISSION ORDER GIVING NOTICE
FOR RESPONSES TO EX PARTE DISCLOSURES**

On March 17, 1993, two members of the Public Utilities Commission staff filed "Notices Pursuant To Rule 9." See, Rule 9(e) of the Commission's Rules of Practice and Procedure, 4 Colorado Code of Regulations ("CCR") 4-723-1. The notices state that off-the-record communications have occurred in this docket between one staff member, an Assistant Attorney General and the Administrative Law Judge.

Rule 9 provides that other parties to the proceeding shall have an opportunity to respond to such disclosures.

THEREFORE THE COMMISSION ORDERS THAT:

1. Any party that desires to file a response to the "Notices Pursuant to Rule 9" must file such response by March 31, 1993. The response must include a statement of what relief, if any, the party is requesting.
2. The April 1, 1993 special open meeting is hereby vacated, which was previously set to discuss exceptions filed by Aspen Limousine Service, Inc. to Decision No. R93-148, and parties' responses to the exceptions. The special open meeting will be reset at a later date after the Commission has an opportunity to consider any responses that may be filed regarding the "Notices Pursuant To Rule 9."
