**COMMISSION ORDER GRANTING TIME SCHEDULE CHANGES
ON LESS-THAN-STATUTORY NOTICE**

STATEMENT, FINDINGS, AND CONCLUSIONS

BY THE COMMISSION:

On July 14, 1993, Black Hawk Central City Ace Express, Inc. (BHCE), filed an application for an order of the Commission authorizing the publication of Passenger Time Schedule No. 10, to become effective on less-than-statutory notice.

BHCE operates scheduled service between points in Denver and Central City/Black Hawk. BHCE has been providing service between these points since October 1, 1991.

In its application, BHCE proposes to add one daily round-trip between points in Denver and Central City/Black Hawk. BHCE also eliminates one one-way trip from Central City/Black Hawk to Denver.

In support of this application, BHCE states that the one-way trip to be eliminated is very lightly used and was scheduled too close to the prior and subsequent trip to Denver to allow the vehicle to effectively complete all three schedules at the published time.

Analysis of this application has determined that the proposed revisions in service are acceptable under BHCE's authority and the requested level of service is adequate. The granting of the application on less-than-statutory notice is required to better serve the public.

Rule No. 31(f)(1) of the Commission's Rules of Practice and Procedure, 4 Code of Colorado Regulations 723-1, states that an order authorizing common carriers to change tariffs or time schedules on less-than-statutory notice will be entered for good cause shown.

The Commission finds that good cause has been shown for approval of the proposed changes in Time Schedule No. 10, and the application should be granted.

THEREFORE THE COMMISSION ORDERS THAT:

1. The application of Black Hawk Central City Ace Express, Inc. to publish Time Schedule No. 10, to become effective on less-than-statutory notice, is granted.

2. Time Schedule No. 10, as set forth in attached Appendix A, shall be published and filed to become effective on not less than one day's notice to the Commission and the general public.

This Order is effective on its mailed date.
