- 1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on March 24, 1995.

The failure to file a written request either for an extension of suspension or reinstatement of the certificate and filing of insurance and tariffs will result in revocation of the authority without further notice and without the right to reinstatement.
