**COMMISSION ORDER
GRANTING EXTENSION OF
PERMANENT AUTHORITY**

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on April 18, 1995.
2. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed.

This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
3. On April 3, 1995, the Applicant filed a restrictive amendment to its application. This amendment further restricts the application in that it restricts the Applicant from

providing service to points in the County of Lake, State of Colorado. The evidence submitted warrants the grant of authority as amended by the Applicant.

4.The present or future public convenience and necessity requires, or will require, the transportation service as requested.

5.Applicant is fit, willing, and able to properly perform the extended service as requested.

II.ORDER

A.The Commission Orders That:

1.The hearing set for April 18, 1995 is hereby vacated.

2.This application was deemed complete on March 21, 1995, within the meaning of § 40-6-109.5., C.R.S.

3.Applicant is authorized to extend operations under Certificate of

Public Convenience and Necessity PUC No. 49180 as follows:
Transportation of passengers, in sight- seeing service,

between all points in the County of Summit, State of Colorado,
and between said points, on the one hand, and
all points in the State of Colorado, on the other
hand.

This application is restricted (1) to providing service which
both originates and terminates in the County
of Summit, State of Colorado; (2) against
providing service to Central City or Black Hawk,
Colorado; and (3) against providing service to
points in the County of Lake, State of Colorado.

4.The complete authority under Certificate of Public Convenience and Necessity PUC No. 49180 as extended, shall be as set forth in the attached Appendix.

5.Applicant, as the holder of Certificate of Public Convenience and Necessity PUC No. 49180, shall operate in accordance with the Order of the Commission except when prevented by an Act of God, the public enemy, or extreme conditions.

6.Applicant shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Applicant shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Operations may not begin until these requirements have been met. If the Applicant does not comply with the requirements of this ordering paragraph within 60 days of the effective date of this Order, then ordering paragraph 1 above, which grants authority to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.

B.This Order is effective on its Mailed Date.

On April 6, 1995, the Commission issued Decision No. C95-324, granting Casino Coach, Inc. authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 49180.

This Errata Notice amends the Appendix of Decision No. C95-324 to read as follows:

Transportation of passengers,

I. In scheduled service,

a. Between Breckenridge, Colorado and Central City, Colorado; and

b. Between Copper Mountain, Colorado and Central City, Colorado.

Transportation service under part (a) and (b) are to be provided via Colorado State Highways 9 and 91, Interstate 70, U.S. Highway 6, and Colorado State Highway 119, serving all intermediate points.

II. In sightseeing service,

between all points in the County of Summit, State of Colorado, and between said points, on the one hand, and all points in the State of

Colorado, on the other hand.

This authority is restricted as follows:

A.Item (I) (a) is restricted against providing transportation service that both originates and terminates within a five-mile radius of Black Hawk, Colorado.

B.Item (I) (b) is restricted against providing transportation service that does not either originate or terminate in the County of Summit, State of Colorado.

C.Item (II) is restricted:

- 1.To providing service which both originates and terminates in the County of Summit, State of Colorado;
- 2.Against providing service to Central City or Black Hawk, Colorado; and
- 3.Against providing service to points in the County of Lake, State of Colorado.
