I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on April 26, 1995.
2. No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without an oral hearing.

3.To grant the request for a suspension would be in the public interest.

4.The evidence submitted warrants the approval of a suspension of Part A of Certificate of Public Convenience and Necessity PUC No. 48776 as here ordered.

II.ORDER

A.The Commission Orders That:

1.The hearing set for April 26, 1995, is hereby vacated.

2.This application was deemed complete on April 3, 1995, within the meaning of § 40-6-109.5.

3.The suspension of motor vehicle operations under Part A of Certificate of Public Convenience and Necessity PUC No. 48776 is authorized by the Commission from March 30, 1995 through September 27, 1995.

4.On or before July 27, 1995, Applicant shall file a written request either for an extension of this suspension period, or a request to reinstate Part A of Certificate of Public Convenience and Necessity PUC No. 48776. Prior to reinstatement, insurance and tariffs shall be filed. The failure to file a written request either for an extension of suspension or reinstatement of Part A of the certificate, and filing of insurance and tariffs, will result in revocation of Part A of the authority without further notice and without the right to reinstatement.

B.This Order is effective on its Mailed Date.
