**COMMISSION ORDER
GRANTING ABANDONMENT**

I. BY THE COMMISSION:

Statement, Findings and Conclusion

1. On March 14, 1995, this application was filed with the Commission seeking approval to abandon that portion of Certificate of Public Convenience and Necessity PUC No. 46968 which authorizes transportation services to be provided between the 1st day of November and the 1st day of April of each year.
2. The Commission, by Notice of Applications Filed dated March 20, 1995, gave notice of the filing of this application to all interested persons, firms, and corporations under § 40-6-108(2), C.R.S.

3.The Commission has not received any petitions to intervene or otherwise participate in this proceeding by any person within the time prescribed. This matter is noncontested and may be determined, under § 40-6-109(5), C.R.S., without a hearing.

4.The application to abandon the authority is in the public interest and should be granted.

II.ORDER

A.The Commission Orders That:

1.The hearing set for May 16, 1995 is hereby vacated.

2.This application was deemed complete on May 3, 1995, within the meaning of § 40-6-109.5.

3.The application to abandon that portion of Certificate of Public Convenience and Necessity PUC No. 46968, which authorizes transportation services to be provided between the 1st day of November and the 1st day of April of each year, is granted.

4.The complete authority under Certificate of Public Convenience and Necessity PUC No. 46968 as restricted, shall be as set forth in the attached Appendix.

5.Applicant shall cause to be filed with the Commission a proper tariff, and shall pay the issuance fee. Operations shall not be restricted until these requirements have been met. If the Applicant does not comply with the requirements of this ordering paragraph within 60 days

of the effective date of this Order, then ordering paragraph 1 above, which grants the abandonment to the Applicant, shall be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.

B. This Order is effective on its Mailed Date.
