COMMISSION ORDER GRANTING EXTENSION OF PERMANENT AUTHORITY

I.BY THE COMMISSION:

A.Statement, Findings, and Conclusion

- 1.Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on June 29, 1995.
- 2.No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested.
 Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

- 3. The evidence submitted warrants the grant of authority as requested.
- 4. The present or future public convenience and necessity requires, or will require, the transportation service as requested.
- 5.Applicant is fit, willing, and able to properly perform the extended service as requested.

II.ORDER

A. The Commission Orders That:

- 1. The hearing set for June 29, 1995 is hereby vacated.
 - 2. This application was deemed complete on May 17, 1995, within the meaning of § 40-6-109.5., C.R.S.
 - 3.Applicant is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. 26871 as follows:
- Transportation of passengers and their baggage, in sightseeing service,
 - between all points within a 100-mile radius of the United States Post Office in Telluride, Colorado.
 - This application is restricted to providing service which both originates and terminates in the County of San Miguel, State of Colorado.
 - 4. The complete authority under Certificate of Public Convenience and Necessity PUC No. 26871, as extended, shall be as set forth in the attached Appendix.
 - 5. Applicant, as the holder of Certificate of Public Convenience

and Necessity PUC No. 26871, shall operate in accordance with the Order of the Commission except when prevented by an Act of God, the public enemy, or extreme conditions.

6.Applicant shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Applicant shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Operations may not begin until these requirements have been met. If the Applicant does not comply with the requirements of this ordering paragraph within 60 days of the effective date of this Order, then ordering paragraph 1 above, which grants authority to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.

B. This Order is effective on its Mailed Date.

I.Transportation, in taxi service, of

a.passengers and their baggage; and

b.packages and parcels,

between all points within a 100-mile radius of the United States Post Office at Telluride, Colorado.

II.Transportation of

passengers and their baggage, in call-and-demand limousine service, and charter service,

between all points within a 100-mile radius of the United States Post Office of Telluride, Colorado.

III. Transportation of

passengers and their baggage, in sightseeing service,

between all points within a 100-mile radius of the United States Post Office in Telluride, Colorado.

This authority is restricted as follows:

A.Item I is restricted -

- 1. With regard to Mesa County, service must either originate or terminate in Telluride, Colorado, and provide service to or from any commercial aviation airport or bus terminal in Mesa County;
- 2.To the use of equipment with a passenger capacity of eight or less, including the driver;
- 3. Against providing transportation originating at the La Plata County Airport; and
- 4.Against providing transportation originating in the County of Archuleta, State of Colorado.

- B.Item II is restricted -
- 1. Against providing service between Gunnison, Colorado and Crested Butte, Colorado;
- 2.Against providing service to, from, or between points located within a ten-mile radius of the intersection of Elk Avenue and Colorado State Highway 135 in Crested Butte, Colorado;
- 3. Against providing service to, from, or between points in Aspen and Snowmass, Colorado;
- 4.a.Operations to or from Montrose County are restricted to pick-up or discharge of passengers and their baggage at the Montrose County Airport and/or the bus terminal; and
- b. The holder of the call-and-demand limousine and charter authority in this certificate shall be allowed to have an office in Montrose County only at the Montrose County Airport between the dates of November 15 and April 15, inclusive:
- 5.a.Against providing service between points in Mesa County, Colorado; and
- b.Against pick-up of passengers and their baggage within a ten-mile radius of 12th Street and North Avenue in Grand Junction, Colorado.
- 6.Against providing service to, from, or between points in San Juan, Archuleta, and La Plata Counties, Colorado.
- C.Item III is restricted -
- To providing service which both originates and terminates in the County of San Miguel, State of Colorado.
