#### A.Statement, Findings, and Conclusion

- 1.Proper notice of the filing of this application has been given under \$ 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on July 27, 1995.
- 2.No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be deter-mined without an oral hearing.

- 4.On or before September 30, 1995, Applicant shall file a written request either for an extension of this suspension period, or a request to reinstate Certificate of Public Convenience and Necessity PUC No. 47049.

  Prior to reinstatement, insurance and tariffs shall be filed. The failure to file a written request either for an extension of suspension or reinstatement of the certificate and filing of insurance and tariffs

will result in revocation of the authority without

further notice.
