**I. BY THE COMMISSION:**

**Statement:**

1. This matter comes before us for consideration of exceptions to Decision No. R95-605 filed by Jeffrey Scott, doing business as Invitation to Adventure ("Respondent"). In Decision No. R95-605, the Administrative Law Judge ("ALJ") recommended revocation of the Respondent's operating authorities. That recommendation was based upon Respondent's failure to maintain a currently effective Certificate of Insurance on file with the Commission.
2. On July 20, 1995, Respondent filed exceptions to the ALJ's decision.  
  
As grounds for its request, Respondent states that it timely paid its insurance premium to the agent responsible

for filing the necessary insurance forms with the Commission, and that this insurance agent led Respondent to believe that all necessary filings would be made in a timely manner. Furthermore, Respondent claims that there were no operations under Certificate of Public Convenience and Necessity PUC No. 20374S between June 19, 1995 and July 10, 1995, which is the time period in question.

3. Respondent has filed for a waiver of the Commission's insurance requirements for this time period, and the matter is scheduled to be heard before an ALJ on October 5, 1995.

In order to preserve this authority until such time as Respondent's waiver request may be heard, the Commission shall grant the exceptions.

## **II. ORDER**

1. The exceptions to Decision No. R95-605 filed by Jeffrey Scott, doing business as Invitation to Adventure, are granted.

2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

3.This Order is effective on its Mailed Date.
