I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on November 1, 1995.
2. No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without an oral hearing.

- 3.To grant the request for a suspension would be in the public interest.
- 4.The evidence submitted warrants the approval of a suspension of
a portion of Certificate of Public Convenience and
Necessity PUC No. 22485 as here ordered.

II.ORDER

A.The Commission Orders That:

- 1.The hearing set for November 1, 1995 is hereby vacated.
- 2.This application was deemed complete on September 11, 1995, within
the meaning of § 40-6-109.5, C.R.S.
- 3.The suspension of motor vehicle operations under Part II of
Certificate of Public Convenience and Necessity PUC
No. 22485 is authorized by the Commission from August
1, 1995 through November 1, 1995.
- 4.On or before October 1, 1995, Applicant shall file a written request
either for an extension of this suspension period,
or a request to reinstate Part II of Certificate of
Public Convenience and Necessity PUC No. 22485. The
failure to file a written request either for an
extension of suspension or reinstatement of
Part II of

the certificate will result in revocation of said part without further
notice.
