**COMMISSION ORDER
GRANTING LEASE OF AUTHORITY**

Mailed date: November 6, 1995
Adopted date: November 1, 1995

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
2. The evidence submitted warrants approval of the lease as requested by the Applicant. The Lessee shall be authorized to

lease, for a period of one year, that portion of Part (1) (B) of Certificate of Public Convenience and Necessity PUC No. 13123 which authorizes the transportation of passengers, in taxi service, between all points in the County of Summit, State of Colorado.

3. The financial standing of the Lessee has been satisfactorily established. The lease is in the public interest.

4. Lessee is fit, willing, and able to properly engage in bona fide motor carrier operations under the authority to be leased.

II. ORDER

A. The Commission Orders That:

1. The hearing set for December 19, 1995 is hereby vacated.

2. This application was deemed complete on October 26, 1995, within the meaning of § 40-6-109.5., C.R.S.

3. Duane W. Weisbeck, doing business as Ridge Taxi Service, is authorized to lease, from Resort Express, Inc., Lessor, that portion of Part (1) (B) of Certificate of Public Convenience and Necessity PUC No. 13123 which authorizes transportation of passengers, in taxi service, between all points in the County of Summit, State of Colorado. The lease shall be valid for a period of one year, from

November 6, 1995, the Mailed Date of this Order, through November

6, 1996.

4. Lessee shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Lessee shall also adopt the tariff of the Lessor which shall become that of Lessee until changed according to law. Lessee shall pay the vehicle identification fee. Lessor and Lessee shall file an acceptance of lease signed by both parties. Operations may not begin until these requirements have been met. If the Applicants do not comply with the requirements of this ordering paragraph within 60 days of the effective date of this order, then ordering paragraph 1 above, which grants authority to the Lessee, shall be void, and the lease of authority granted shall be void.
5. The right of Lessee to operate under this Order shall depend on compliance with all present and future laws and Commission reports, if any, covering operations under the Certificate up to the time of the lease.

B. This Order is effective on its Mailed Date.
