**I. BY THE COMMISSION:**

**Statement Findings, and Conclusion**

1. On October 10, 1995, Four Winds, Inc., doing business as People's Choice Transportation, Inc., filed an application (Docket No. 95A-486CP-Extension-TA) for temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 48716 to include the transportation of passengers and their baggage, in scheduled service, between the facilities of the Best Western Denver West Hotel, located at 11595 West 6th Avenue, Lakewood, Colorado, on the one hand, and points within Black Hawk and Central City,

Colorado, on the other hand.

- 2.The Commission gave notice of the application on October 16, 1995. Interventions opposing a grant of the application were filed by Casino Transportation, Inc., Boulder Airporter, Inc., Golden West Commuter, LLC, and Valera Lea Holtorf, doing business as Dashabout Shuttle Company and/or Roadrunner Express "(Dashabout)".
- 3.Dashabout holds no authority to provide service to or from points in Black Hawk or Central City, Colorado, and as such, it does not have standing to intervene in this application. Dashabout's intervention should be dismissed.
- 3.By § 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.
- 4.Pursuant to § 40-6-120(1), C.R.S., the Commission is authorized to grant temporary authority when there appears to be an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need.
- 5.It cannot be found that there is an unmet immediate and urgent need for the proposed service. There

are existing carriers, which have not been approached, who are capable

of providing the requested service.

6.The Commission finds due to the facts stated in paragraph 5 above, there is no immediate and urgent need for additional transportation services. The Commission will deny the application.

7.This application for temporary authority is not in the public interest and should be denied.

## **II.ORDER**

### **A.The Commission Orders That:**

1. This application is denied.
- 2.The intervention of Valera Lea Holtorf, doing business as Dashabout Shuttle Company and/or Roadrunner Express, is dismissed for lack of standing to intervene.
- 3.The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
