**I. BY THE COMMISSION:**

**Statement Findings, and Conclusion**

1. On November 8, 1995, Valera Lea Holtorf, doing business as Dashabout Shuttle Company and/or Roadrunner Express, filed an application (Docket No. 95A-530CP-Extension-TA) for temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 14167 by sub-stituting the words "Denver International Airport" for the words "Stapleton International Airport" in restriction (I) (2) of said certificate.

2. The Commission gave notice of the application on November 13, 1995. An intervention opposing a grant of the application was filed by Boulder Airporter, Inc.
3. By § 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.
4. Pursuant to § 40-6-120(1), C.R.S., the Commission is authorized to grant temporary authority when there appears to be an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need.
5. Restriction (I) (2) in Certificate of Public Convenience and Necessity PUC No. 14167 refers only to the intermediate points authorized to be served along the carrier's scheduled route between Wray and Fairplay, Colorado. The specific intermediate service points named in this restriction must lie within a 16-mile radius of Colfax Avenue and Broadway, in Denver, Colorado. Denver Inter-national Airport does not lie within this radial and, therefore, substituting the words "Denver International Airport" for the words "Stapleton International Airport" will have no net effect on operations allowed under said certificate. Thus,

there can be no immediate and urgent need for the requested service.

6.The Commission finds, due to the facts stated in paragraph 5 above,  
that this application for temporary authority is not  
in the public interest and should be denied.

## **II.ORDER**

### **A.The Commission Orders That:**

1. This application is denied.
- 2.The 20-day time period provided by § 40-6-114(1), C.R.S., to file  
an application for rehearing, reargument, or  
reconsideration shall begin on the first day after  
the Commission mails or serves this Decision.
