**I. BY THE COMMISSION:**

**A. Statement, Findings, and Conclusion**

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on January 22, 1996.
2. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.
3. The evidence submitted warrants the grant of authority as requested.

4.The present or future public convenience and necessity requires, or will require, the transportation service as requested.

5.Applicant is fit, willing, and able to properly perform the extended service as requested.

## **II.ORDER**

### **A.The Commission Orders That:**

1.The hearing set for January 22, 1996 is hereby vacated.

2.This application was deemed complete on December 13, 1995, within the meaning of § 40-6-109.5, C.R.S.

3.Applicant is authorized to extend operations under Certificate of Public Convenience and Necessity PUC No. 26246 as follows:

Transportation of passengers and their baggage, in scheduled service,

between all points within a 35-mile radius of the intersection of U.S. Highway 40 and Mount Werner Road at or near Steamboat Springs, Colorado.

This application is restricted to serving points named in the carrier's filed schedule.

4.The complete authority under Certificate of Public Convenience and Necessity PUC No. 26246 as extended, shall be as set forth in the attached Appendix.

5.Applicant, as the holder of Certificate of Public Convenience and Necessity PUC No. 26246, shall operate in

accordance with the Order of the Commission except when prevented by an Act of God, the public enemy, or extreme conditions.

6. Applicant shall cause to be filed with the Commission certificates of insurance as required by Commission rules. Applicant shall file a proper tariff and pay the issuance fee and annual vehicle identification fee. Operations may not begin until these requirements have been met. If the Applicant does not comply with the requirements of this ordering paragraph within 60 days of the effective date of this Order, then ordering paragraph 1 above, which grants authority to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 60 days.

**B.** This Order is effective on its Mailed Date.

Transportation of

I.Passengers and their baggage, in taxi, charter, and call-and-demand limousine service,

a.between all points in the County of Routt, State of Colorado;  
and

b.between all points in the County of Routt, State of Colorado, on the one hand, and all points in the State of Colorado, on the other hand.

II.Passengers and their baggage,

between Stapleton International Airport and Steamboat Springs, Colorado via I-70, U.S. Highway 40, and Colorado State Highways 9 and 131, serving all intermediate points in Routt County, Colorado, and serving all other points in the County of Routt, State of Colorado, as off-route points.

III.Passengers and their baggage,

between Craig, Colorado and Steamboat Springs, Colorado and points within 5 miles thereof via U.S. Highway 40 serving all intermediate points, including the Yampa Valley Regional Airport and the Steamboat Stolport.

IV.Passengers and their baggage, on schedule,

between Steamboat Springs, Colorado, on the one hand, and Aspen and Vail, Colorado, on the other hand.

V.Passengers and their baggage, on schedule,

between Denver International Airport and Steamboat Springs, Colorado, via U.S. Interstate Highway 70, U.S. Highway 40, and Colorado Highways 9 and 131; serving the Greyhound bus depot in the City and County of Denver as on off-route point; serving all intermediate points in Routt County, Colorado, serving Silverthorne and Kremmling, Colorado, as additional intermediate points and serving all other points in the County of Routt, State of Colorado, as off-route points.

Appendix

VI. passengers and their baggage, in scheduled service,  
between all points within a 35-mile radius of the intersection of  
U.S. Highway 40 and Mount Werner Road at or near Steamboat  
Springs, Colorado.

This certificate is restricted as follows:

A. Item I(b) against

1. providing service from points in Pitkin County to points in  
Routt County; and

2. service from Routt County to Pitkin County shall be limited to  
providing service from all points within a 12-mile radius  
of the intersection of U.S. Highway 40 and Mt. Werner Road  
in Steamboat Springs, Colorado, to all points within a 12-mile  
radius of the intersection of Mill and Maine in Aspen,  
Colorado, between the dates of November 15 through April 15,  
inclusive;

B. Charter service authorized in Item I against the use of vehicles  
with a passenger capacity of 32 or more;

C. Part V is restricted against providing service between Denver  
International Airport and the Greyhound bus depot in the City  
and County of Denver. Additionally, Part V is also restricted  
against providing service between Denver International Airport  
and the Greyhound bus depot in the City and County of Denver,  
on the one hand, and Silverthorne, Colorado, on the other hand;  
and

D. All scheduled operations are restricted to serving points named  
in the carrier's filed schedule.
