**COMMISSION ORDER GRANTING
TEMPORARY AUTHORITY**

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. On December 6, 1995, Coyne Krupske and Troy Walker, doing business as Rocky Mountain Shuttle Service, filed an application (Docket No. 95A-577CP-TA) for temporary authority to conduct operations as a common carrier by motor vehicle for hire for the transportation of passengers and their baggage, on schedule, between the Wagon Wheel Park-and-Ride located near the intersection of Interstate 25 and 120th Avenue, on the one hand, and the Colorado Springs Municipal Airport, in Colorado Springs, Colorado, on the other

hand, with service to the intermediate point of the Arapahoe Park-and-Ride located near the intersection of Interstate 25 and Arapahoe Road.

2.The Commission gave notice of the application on December 11, 1995.

No interventions opposing a grant of the application were filed.

3.By § 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.

4.Pursuant to § 40-6-120(1), C.R.S., the Commission is authorized to grant temporary authority when there appears to be an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need.

5.The support filed on behalf of this application indicates that the Colorado Springs Municipal Airport is becoming an increasingly popular destination for travelers, and as such, an immediate and urgent need for the service requested has developed.

6.The Commission finds that there is an immediate and urgent need for additional transportation services, and will grant the application.

7.The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority sought and is willing, ready, and able to operate under all Commission rules and regulations

governing carriers by motor vehicle.

8.This application for temporary authority is in the public interest and should be granted.

9.The Applicant is advised that the granting of a temporary authority makes no presumption that permanent authority will be granted.

II. ORDER

A.The Commission Orders That:

1.Coyne Krupske and Troy Walker, doing business as Rocky Mountain Shuttle Service, is granted temporary authority to conduct operations as a common carrier by motor vehicle for hire for a period of 180 days commencing from the Mailed Date of this Order, with authority as set forth in the attached Appendix.

2.Coyne Krupske and Troy Walker, doing business as Rocky Mountain Shuttle Service, shall not commence operation until all requirements have been met and notice in writing has been received from the Commission that the Applicant is in compliance and may begin service. If the Applicant does not comply with the requirements of this ordering paragraph within 30 days of the effective date of this Order, then ordering paragraph 1 above, which grants authority to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may

grant additional time for compliance, if the request
for additional time is filed within the 30 days.

3. The 20-day time period provided by § 40-6-114(1), C.R.S., to file
an application for rehearing, reargument, or
reconsideration shall begin on the first day after
the Commission mails or serves this Order.
B. This Order is effective on its Mailed Date.
