**I. BY THE COMMISSION:**

**Statement**

1. On November 21, 1995, Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc. (DASH), filed an application (Docket No. 95A-546CP-Extension-TA) for temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 82 for the transportation of passengers and their baggage, on schedule, between all points within the City and County of Denver, State of Colorado, on the one hand, and the Colorado Springs Municipal Airport, Colorado Springs, Colorado, on the other hand, serving

all intermediate points on and within two miles of Interstate 25, between Denver and the Colorado Springs Municipal Airport, and serving all points located on and within one mile of Interstate 225 as off-route points. This application is restricted to serving only those points named in the carrier's schedule filed with the Public Utilities Commission.

2.The Commission gave notice of the application on November 27, 1995. Interventions opposing a grant of the application were filed by Greater Colorado Springs Transportation Company, doing business as Yellow Cab of Colorado Springs ("YCCS"), Neil J. DeRiso, doing business as Airport Boulevard Company ("ABC"), and Synergistics, Inc., doing business as Colorado Springs Airport Shuttle Services, Inc., ("Synergistics"). Petitions for permissive intervention were filed by Gateway Transportation, LLC, doing business as The Falcon Run ("Gateway"), and BBB Transportation, Inc., doing business as Overland Airport Express, Inc. ("Overland").

3.On December 12, 1995, DASH filed a petition for permission to file rebuttal to interventions of Synergistics, ABC, and YCCS. On December 19, 1995, responses to said petition were filed by Synergistics, ABC, and YCCS. Also, on December 19, 1995, DASH filed a restrictive

amendment which limits the scope of the authority sought against providing service originating or terminating at Denver International Airport or Stapleton International Airport; and against serving intermediate points in Douglas and El Paso Counties.

4. By § 40-6-120, C.R.S., the application for temporary authority is under consideration for a Commission order.

5. Pursuant to § 40-6-120(1), C.R.S., the Commission is authorized to grant temporary authority when there appears to be an immediate and urgent need to any point or within a territory having no carrier service capable of meeting such need.

### **Findings**

1. The support filed on behalf of this application is in the form of five letters from different hotels in the Denver metropolitan area, each indicating a need for service to and from their individual hotels.

2. There is no support for, or any indication of a need for service which cannot be provided by an existing carrier, between the Colorado Springs Municipal Airport and points in Douglas or El Paso Counties, State of Colorado. Also, there is no support for service along Interstate 225.

3. At present, there is no scheduled carrier service available between points within the City and County of Denver, including

the City of Glendale, and points within two miles of Interstate 25, between Belleview Avenue and County Line Road, on the one hand, and the Colorado Springs Municipal Airport, on the other hand.

### **Conclusion**

- 1.The standard for granting a temporary authority is, in part, that there is no carrier service available. The Commission is aware that Gateway is presently seeking permanent authority to provide service which, if granted, would duplicate a portion of the instant application. However, Gateway is not now providing service to the public, nor does it hold any authority in conflict with this application. Gateway's petition to intervene will be granted due to the potential conflict with the authority requested.
- 2.Since DASH has restricted its application against providing service which conflicts with the authority held by Overland, the petition to intervene filed by Overland is now moot, and as such will be denied.
- 3.The petition of DASH for permission to file rebuttal will be denied.
- 4.The Commission finds that there is no scheduled carrier service available between the Colorado Springs Municipal Airport, on the one hand, and, on the other hand, points within the City and County of Denver, including the City of Glendale, and points within two miles of

Interstate 25, between Belleview Avenue and County Line Road. This application for temporary authority is in the public interest and will be granted, in part.

5.The Applicant has adequate equipment and financial resources to begin immediate service within the scope of the authority granted and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.

6.The Applicant is advised that the granting of a temporary authority makes no presumption that permanent authority will be granted.

## **II. ORDER**

### **A.The Commission Orders That:**

1.The petition to intervene filed on behalf of Gateway Transportation, LLC, doing business as The Falcon Run, is granted.

2.The petition to intervene filed on behalf of BBB Transportation, Inc., doing business as Airport Express, Inc., is denied.

3.The petition of Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc., to file rebuttal to the interventions of Greater Colorado Springs Transportation Company, doing business as Yellow Cab of Colorado Springs ("YCCS"), Neil J. DeRiso, doing business as Airport Boulevard Company

("ABC"), and Synergistics, Inc., doing business as Colorado Springs Airport Shuttle Services, Inc., is denied.

4. Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc., is granted temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 82 for a period of 180 days commencing from the Mailed Date of this Order, with authority as set forth in the attached Appendix.

5. Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc., shall not commence operation until all requirements have been met and notice in writing has been received from the Commission that the Applicant is in compliance and may begin service.

If the Applicant does not comply with the requirements of this ordering paragraph within 30 days of the effective date of this Order, then ordering paragraph 1 above, which grants authority to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 30 days.

6. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or

reconsideration shall begin on the first day after  
the Commission mails or serves this Decision.

**B.** This Order is effective on its Mailed Date.
