**COMMISSION ORDER
GRANTING ENCUMBRANCE**

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

2. Pennsylvania Coach Lines, Inc. seeks authority to encumber all right, title, and interest in and to Certificate of Public Convenience and Necessity PUC No. 46073, owned and operated by Transportation Associates of

Colorado, Inc. ("Transportation Associates"). The requested encumbrance is to secure payment of the indebtedness in the principal sum of \$47,450.09, in accordance with the judgement against Transportation Associates secured in Civil Action Number 94CV-00629, Division A, District Court for the County of Adams, State of Colorado, and entered on the Registry of Judgements on September 29, 1995. Transportation Associates of Colorado, Inc. and Pennsylvania Coach Lines, Inc. shall notify the Commission, in writing, of the full satisfaction of the above-stated indebtedness, and release of the encumbrance authorized herein, within ten days after it has been effected.

3.The evidence submitted warrants the grant of the request to encumber the authority.

4.The approval sought is in the public interest and should be granted.

II. ORDER

A.The Commission Orders That:

1.The hearing set for February 7, 1996 is hereby vacated.

2.This application was deemed complete on January 2, 1996, within the meaning of § 40-6-109.5, C.R.S.

3.Pennsylvania Coach Lines, Inc. is authorized to encumber all right, title, and interest in Certificate of Public

Convenience and Necessity PUC No. 46073, owned and operated by Transportation Associates of Colorado, Inc., to secure payment of the indebtedness in the principal sum of \$47,450.09, in accordance with the judgement against Transportation Associates of Colorado, Inc. secured in Civil Action Number 94CV-00629, Division A, District Court for the County of Adams, State of Colorado, and entered on the Registry of Judgements on September 29, 1995.

4. Transportation Associates of Colorado, Inc. and Pennsylvania Coach Lines, Inc. shall notify the Commission, in writing, of the full satisfaction of the above-stated indebtedness, and release of the authorized encumbrance, within ten days after it has been effected.

B. This Order is effective on its Mailed Date.
