**COMMISSION ORDER

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. On December 20, 1995, Southwest Shuttle Express, Inc., filed an application (Docket No. 95A-614CP-Extension-TA) for temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 50790.

2. The Commission gave notice of the application on December 26, 1995.

An intervention opposing a grant of the application was filed by Yellow Cab Cooperative Association, doing business as Yellow Cab, Inc., and its division, Denver Airport Limousine Service, Inc.

3. On January 5, 1996, the Applicant filed a request to withdraw its application, stating that it intends to refile the application with additional support.

4. Pursuant to 4 CCR 723-1, C.R.S., Rule 22(h)(1) of the Commission's Rules of Practice and Procedure, this application may be withdrawn without prejudice.

II. ORDER

A. The Commission Orders That:

1. The application of Southwest Shuttle Express, Inc. for temporary authority to extend operations under Certificate of Public Convenience and Necessity PUC No. 50790 is dismissed, without prejudice.

2. The 20-day time period provided by § 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.
