**COMMISSION ORDER
GRANTING ENCUMBRANCE**

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of these applications have been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

2. Upon acceptance of transfer of Certificates of Public Convenience and Necessity PUC Nos. 2378&I, 180&I, 174&I, 1198, 150&I, 4302, 177&I, 82, 13175, 2778&I, and Contract Carrier Permit No. B-8254 from Yellow Cab Cooperative Association, Inc., doing business as Yellow Cab, Inc. and Boulder Yellow Cab, Inc., and its division, Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc.; Yellow Transportation, LLC, Denver Taxi, LLC, Boulder Taxi, LLC, and Denver

Shuttle, LLC, seek authority to encumber all right, title, and interest in and to said certificates and permit to Key Bank of Colorado.

3.The requested encumbrance is to secure payment of the indebtedness in the principal sum of \$2,450,000. This sum is comprised of a \$1,300,000 six year note, a \$450,000 Line of Credit, and a \$700,000 three year note.

4.The evidence submitted warrants the grant of the request to encumber the above enumerated certificates and permit upon acceptance of the transfers by the parties.

5.The approval sought is in the public interest and should be granted.

II. ORDER

A.The Commission Orders That:

1.Upon acceptance of transfer of Certificates of Public Convenience and Necessity PUC Nos. 2378&I, 180&I, 174&I, 1198, 150&I, 4302, 177&I, 82, 13175, 2778&I, and Contract Carrier Permit No. B-8254 from Yellow Cab Cooperative Association, doing business as Yellow Cab, Inc. and Boulder Yellow Cab, Inc., and its division, Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc.; Yellow Transportation, LLC, Denver Taxi, LLC, Boulder Taxi, LLC, and Denver Shuttle, LLC, are authorized to encumber all right, title, and interest in said certificates and permit to Key Bank of Colorado, to secure payment of the

indebtedness in the amount of \$2,450,000.

2.The encumbrance authorized herein shall be in accordance with the terms and conditions set forth in the Security Agreement and Financing Statement executed by the parties.

3.A copy of all documents required by Rule 50(g)(10)(B) of the Commission's Rules of Practice and Procedure shall be filed with the Commission within ten days of consummation of said loans.

4.Yellow Transportation, LLC, Denver Taxi, LLC, Boulder Taxi, LLC, Denver Shuttle, LLC, and Key Bank of Colorado shall notify the Commission, in writing, of the full satisfaction of the above-stated indebtedness, and release of the authorized encumbrance, within ten days after it has been effected.

B.This Order is effective on its Mailed Date.
