**I. BY THE COMMISSION:**

**Statement, Findings and Conclusion**

1. On December 4, 1995, this application was filed with the Commission seeking approval to abandon the authority under Certificate of Public Convenience and Necessity PUC No. 53656.
2. The Commission, by Notice of Applications Filed dated December 11, 1995, gave notice of the filing of this application to all interested persons, firms, and corporations under § 40-6-108(2), C.R.S.
3. The Commission has not received any petitions to intervene or otherwise participate in this proceeding by any

person within the time prescribed. This matter is noncontested and may be determined, under § 40-6-109(5), C.R.S., without a hearing.

4.The application to abandon the authority is in the public interest and should be granted.

1.The hearing set for March 6, 1996 is hereby vacated.
