**COMMISSION ORDER
GRANTING SUSPENSION**

I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. Also at that time, this matter was set for hearing before the Commission on March 7, 1996.
2. No protest, objection, or petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is therefore noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without an oral hearing.

- 3.To grant the request for a suspension would be in the public interest.
- 4.The evidence submitted warrants the approval of a suspension of Certificate of Public Convenience and Necessity PUC No. 47966 which authorizes the transportation of passengers and their baggage, on schedule, between points in the Counties of Fremont and Douglas, State of Colorado, on the one hand, and Cripple Creek, Colorado, on the other hand, as here ordered.

II. ORDER

A.The Commission Orders That:

- 1.The hearing set for March 7, 1996 is hereby vacated.
- 2.This application was deemed complete on January 25, 1996, within the meaning of § 40-6-109.5, C.R.S.
- 3.The suspension of motor vehicle operations under Certificate of Public Convenience and Necessity PUC No. 47966 which authorizes the transportation of passengers and their baggage, on schedule, between points in the Counties of Fremont and Douglas, State of Colorado, on the one hand, and Cripple Creek, Colorado, on the other hand, is authorized by the Commission from October 30, 1995 through June 1, 1996.
- 4.On or before April 1, 1996, Applicant shall file a written request either for an extension of this suspension period,

or a request to reinstate that portion of Certificate of Public Convenience and Necessity PUC No. 47966 which is herein suspended. Prior to reinstatement, insurance and tariffs shall be filed. The failure to file a written request either for an extension of suspension or reinstatement of the certificate and filing of insurance and tariffs will result in revocation of the authority without further notice.

B. This Order is effective on its Mailed Date.
