**I. BY THE COMMISSION:**

**A. Statement, Findings, and Conclusion**

1. Proper notice of the filing of this application has been given under § 40-6-108(2), C.R.S. No petition to intervene or otherwise participate in this proceeding has been filed by any person within the time prescribed. This proceeding is noncontested. Under § 40-6-109(5), C.R.S., this matter may be determined without a hearing.

2. Steamboat Transportation Services, Inc., doing business as Steamboat Taxi, Inc., owner and operator of the certificate, seeks approval for the continuation of the encumbrance of Alpine/Limo, Inc. against

Certificate of Public Convenience and Necessity PUC No. 9742, which was granted pursuant to Decision No. R90-1419.

- 3.The evidence submitted warrants the grant of the request to continue the encumbrance of the authority.
- 4.Steamboat Transportation Services, Inc., doing business as Steamboat Taxi, Inc., and Alpine Taxi/Limo, Inc., shall notify the Commission in writing of the full satisfaction of the above-stated indebtedness, and release of the encumbrance authorized herein, within ten days after it has been effected.
- 5.The approval sought is in the public interest and should be granted.

## **II. ORDER**

### **A. The Commission Orders That:**

- 1.The hearing set for March 8, 1996 is hereby vacated.
- 2.This application was deemed complete on January 24, 1996, within the meaning of § 40-6-109.5, C.R.S.
- 3.Steamboat Transportation Services, Inc., doing business as Steamboat Taxi, Inc., is authorized to continue the encumbrance of all right, title, and interest in Certificate of Public Convenience and Necessity PUC No. 9742 to Alpine Taxi/Limo, Inc., - 2 -  
according to the terms agreed to by the Parties in the Uniform Commercial Code Financing Statement UCC-1 and continued by UCC-3 (filing No. 952088149), filed with the Colorado Secretary of State.

4.Steamboat Transportation Services, Inc., doing business as Steamboat Taxi, Inc., and Alpine Taxi/Limo, Inc., shall notify the Commission, in writing, of the full satisfaction of the abovestated indebtedness, and release of the authorized encumbrance, within ten days after it has been effected.
