**COMMISSION ORDER GRANTING APPLICATION  
FOR AN EXTENSION OF TIME**

**I. BY THE COMMISSION:**

## **A. Statement, Findings, and Conclusion**

1. On December 13, 1995, we adopted Decision No. C95-1260.

This decision transferred Certificates of Public Convenience and Necessity PUC Nos. 82, 277&I, 150&I, 174&I, 177&I, 180&I, 1198&I, 2378&I, 13175, and Contract Carrier Permit No. B-8254, from Yellow Cab Cooperative Association, Inc., doing business as Yellow Cab, Inc. and Boulder Yellow Cab, Inc., and Denver Airport Limousine Service, Inc., doing business as Denver Airport Shuttle, Inc., to Denver Taxi, LLC, Boulder Taxi, LLC, and Denver Shuttle, LLC. In this decision, we noted that several of the certificates to be transferred contained antiquated or obsolete language, references to carriers no longer in existence, overlapping and duplicative authority, etc. Our decision required the filing of an application to clarify certain authorities within 60 days of the effective date of the order, or February 11, 1996. The purpose of this requirement was to clarify operating authorities which have been in effect for over 50 years.

For example, Certificate No. 177&I states "...applicant shall charge not less than 15¢ per car-mile when transporting passengers for one or more passengers, and 12¢ per mile for dead-head service, that in empty car movement to or from points where loaded movement starts or ends, and shall be further limited to cars carrying not to exceed (5) passengers on any one trip."

2. On February 9, 1996, Boulder Taxi, LLC ("Boulder") filed an application to open a miscellaneous docket for the limited purpose of redrafting Boulder's authorities pursuant to Commission Decision

No. C95-1260, or, in the alternative, to request an extension of time to April 5, 1996 to file an application. We will

construe this pleading as a request for an extension of time in which to file the application required in Decision No. C95-1260.

## **II. ORDER**

### **A. The Commission Orders That:**

1. Boulder Taxi, LLC is granted an extension of time until March 7, 1996 to file an application to redraft Certificates of Public Convenience and Necessity PUC Nos. 150&I, 174&I, 177&I, 180&I and 1198.

2. Boulder Taxi, LLC shall file with the Commission an application to redraft Certificates of Public Convenience and Necessity PUC Nos. 150&I, 174&I, 177&I, 180&I and 1198 for the purpose of eliminating overlapping and duplicating authority, archaic and obsolete language, and references to certificates and motor carriers no longer in existence. If possible, certificates should be merged into one or two operating authorities.

3. Boulder Taxi, LLC shall file this application pursuant to Rule 50 of the Commission's Rules of Practice and Procedure, 4 *Colorado Code of Regulations*, 723-1.

**B.** This Order is effective on its Mailed Date.
