I. BY THE COMMISSION:

Statement, Findings and Conclusion

1. On March 6, 1996, this application was filed with the Commission seeking approval to abandon the authority under Certificate of Public Convenience and Necessity PUC No. 53588.

2. The Commission, by Notice of Applications Filed dated March 18, 1996, gave notice of the filing of this application to all interested persons, firms, and corporations under § 40-6-108(2), C.R.S.

3. The Commission has not received any petitions to intervene or otherwise participate in this proceeding by any person within the time prescribed. This matter is noncontested and may be determined under § 40-6-109(5), C.R.S., without a hearing.

4. The application to abandon the authority is in the public interest and should be granted.

II. ORDER

A. The Commission Orders That:

1. The hearing set for June 11, 1996 is hereby vacated.
 2. This application was deemed complete on May 9, 1996, within the meaning of § 40-6-109.5, C.R.S.
 3. The application to abandon Certificate of Public Convenience and Necessity PUC No. 53588 is granted, and said Certificate is accordingly revoked.
