I.BY THE COMMISSION:

Statement Findings, and Conclusion

- 1. On August 28, 1996, Colorado Tour Line, L.L.C. filed an application (Docket No. 96A-390CP-Transfer-TA) for temporary approval to assume operational control of Certificate of Public Convenience and Necessity PUC No. 55&I pending Colorado Public Utilities Commission consideration of the related application to permanently acquire the certificate from San Juan Tours, Inc.
- 2. The Commission gave notice of the application on September 3, 1996. No interventions opposing a grant of the application were filed.
- 3. By \$ 40-6-120, C.R.S., the application for temporary approval is under consideration for a Commission order.
- 4. Pursuant to § 40-6-120(1), C.R.S., the State Legislature has authorized the Commission to grant temporary approval if it appears that failure to grant such temporary approval may result in destruction of or injury to such carrier or carrier properties sought to be acquired or to interfere substantially with their future usefulness in the performance of adequate and continuous service to the public.
- 5. The support filed on behalf of this application indicates that a failure to authorize the Transferee to temporarily assume

operational control of the certificate could ultimately effect service to the public. Therefore, the Commission finds that this application meets the requirements of \$ 40-6-120(1), C.R.S., and the application shall be granted.

- 6. The Transferee has adequate equipment and financial resources to begin immediate service within the scope of the authority to be operated, and is willing, ready, and able to operate under all Commission rules and regulations governing carriers by motor vehicle.
- 7. This application for temporary approval is in the public interest and should be granted.
- 8. The Applicants are advised that the granting of an temporary approval makes no presumption that a permanent transfer of authority will be granted.

II.ORDER

A. The Commission Orders That:

- 1. Colorado Tour Line, L.L.C. is granted temporary approval to conduct operations under Certificate of Public Convenience and Necessity PUC No. 55&I for a period of 180 days commencing from the Mailed Date of this Order.
- 2. Colorado Tour Line, L.L.C. shall not commence operations until all requirements have been met and notice in writing has been received from the Commission that it is in compliance and may begin service. If Colorado Tour Line, L.L.C does not comply with the requirements of this ordering paragraph within 30 days of the effective date of this Order, then ordering paragraph 1 above, which grants approval to the Applicant, shall be void, and the authority granted shall then be void. On good cause shown, the Commission may grant additional time for compliance, if the request for additional time is filed within the 30 days.
- 3. The 20-day time period provided by \$ 40-6-114(1), C.R.S., to file an application for rehearing, reargument, or reconsideration shall begin on the first day after the Commission mails or serves this Decision.

B. This Order is effective on its Mailed Date.
