I. BY THE COMMISSION:

A. Statement, Findings, and Conclusion

1. On October 28, 1996, the Commission issued its Decision No. C96-1116 granting Queen City Transportation, Inc., doing business as 7NEWSSKIEXPRESS, temporary authority to provide scheduled passenger service between various points in the Denver metropolitan area and the ski resorts, to become effective on December 14, 1996.

On November 19, 1996, Queen City Transportation, Inc., doing business as 7NEWSSKIEXPRESS, requested that the effective date of the decision be advanced to November 29, 1996.

2. The Commission finds that the petition is reasonable and should be granted.
